EXTENSION OF LOW VOLTAGE NETWORK AND POST CONNECTIONS**

Interested experienced electrical contractors registered with the ECB (ELECTRICAL CONTRACTORS BOARD), having a CIDB rating of at least 2EP and who have qualified as electricians with a valid three-phase wireman's license, and in possession of the ORHVS certificate with Modules 1 to 10 are invited to bid for the tender on completing the post connections for the following villages under the Makhado Municipality electricity distribution area: Makhitha, Madzororo, Sane, Mangwele, Matshavhawe, Khunda, and Tshiendeulu. Bidders are requested to bid as per specification attached to the bid documents that will be obtainable on **19 April 2011** at Procurement Office no. B043 upon payment of a non-refundable amount of R200,00.

A compulsory **briefing meeting** will be held on **20 April 2011** at **12:00** in the Council Chamber, Ground Floor Civic Centre, 83 Krogh Street Louis Trichardt.

Completed bid documents signed by a duly authorised person, sealed in an envelope clearly marked "*Tender No. 7 of 2011: Extension of Low Voltage Network and Post Connections*" must reach the undersigned by depositing it into the tender box at the foyer of the main entrance to the Civic Centre by no later than **12:00 on Friday, 29 April 2011** when all tenders received will be opened in public in the Executive Committee Chamber, First Floor, Civic Centre, No. 83 Krogh Street, Louis Trichardt.

The Municipality is not bound to accept the lowest or any bid and reserves the right to accept any part of a bid. Bids must remain valid for a period of ninety (90) days after closing date of submission thereof. Submitted tenders will be evaluated on 90/10 score points.
