	<ul> <li>Construction</li> <li>The capacity of the container must be of 6m<sup>3</sup> and be made of robust design and all welded construction of 4.5mm mild steel plate.</li> <li>The container floor must be strengthened with (longitudinal) corrugations, consisting of twelve bends equally spaced over floor width and the sides with channel sections.</li> <li>The lifting lugs should be of machined type BS 5032 of 1980.</li> <li>The front, back and floor plates must be formed to wrap around the side</li> </ul>
	<ul> <li>plates, edge to edge welded construction is not acceptable.</li> <li>Shape</li> <li>Double sloping tipping side, double tipping bar, and tapered so they are stackable.</li> </ul>
	<ul> <li>Dimension</li> <li>The positioning of the lifting lugs shall be shown on the attached drawing to suit the container handling systems</li> <li>The clearance at the top must be verified by the Bin Manufacturer.</li> </ul>
