Interested and experienced Electrical contractors are hereby invited to bid for the supply, delivery and installation of substation switch gears and control panels with regard to the upgrade of the urban substations of the Municipality's urban electrical network. Bid documents are obtainable upon payment of a non-refundable amount of R300,00 from **09** *December 2015* at the **Procurement Office**, **Office no. B043**.

A compulsory briefing meeting will be held on **15 December 2015 at 12:00** at Stubb Substation next to the N1 Traffic Circle in Makhado town.

Completed bid documents signed by duly authorised person and separately sealed in an envelope marked "Tender No.75 of 2015: Upgrade of Urban Substations" as referred to above, must be deposited into the tender box at the main entrance to the Civic Centre building not later than 23 December 2015 Wednesday at 12:00. Bid documents received on time will be opened in public in the Council Chambers just after the stipulated closing time of the tender.

The Municipality is not bound to accept the lowest or any bid and reserve the right to accept any part of a bid. Bids must remain valid for a period of ninety (90) days after the closing date of the bid. Submitted tenders will be evaluated on 90/10 Score points.

Bids that will be submitted after the stipulated time and date, or incomplete, unsigned, written in pencil, submitted in telegraph or facsimile or any electronic form, or not having the following attachment documents, will be disqualified at the evaluation stage:

- 1. Original and valid Tax Clearance Certificate.
- 2. Copy of company registration certificate.(CK)
- 3. Certified copy/copies of company owner(s) ID book(s).
- 4. BBBEE certificate (for preferential points)
- 5. Be registered with the Department of Labour as Electrical Contractor.
- 6. Proof of qualification as Installation Electrician (Wireman Licensed)
- 7. Copy of valid ORHVS modules 1 to 10 or Level –04 HVO
- 8. Copy of CIDB grade rating of 5EP certificate
- 9. Proof of current payment for municipal bill (accounts or rates)

Bids will be adjudicated under the provisions of the Municipal Finance Management Act 56 of 2003, the Municipal Supply Chain management Policy, and the Regulations promulgated thereof. Bids will be evaluated on the basis of a minimum Functionality threshold of 70 points, meaning that Bidders who score less than 70 points on Functionality won't be considered for further evaluation. The Functionality criteria are as follows:
