Makhado Local Municipality hereby invites nominations for members of the public to be appointed as members of its (1) Municipal Planning Tribunal, or (2) Municipal Appeal Authority. Members will serve for a period of five (5) years calculated from the date of appointment by Municipality.

**Fields/Areas of interest:** Town planning, Land use Survey, Electrical Engineering, Civil Engineering, Environmental Management, Hydrology and Legal.

Nominees must be persons with leadership qualities and must have knowledge and experience of spatial planning, land use management and land development or the law related thereto, as required in section 36(1) (b) and section 51(6) of the Spatial Planning and Land Use Management Act, No 16 of 2013.

Each nomination must be in writing and must contain the following information.

(a) The name and address of the nominator, who must be a natural person and a person may nominate himself or herself

(b) The name, address and identity number of the nominee

(c) Motivation by the nominator for the appointment of the nominee to the Municipal Planning Tribunal not exceeding one A4 page

(d) Certified copies of qualifications and registration certificates indicating registration with the relevant professional body or voluntary association.

(e) Discloser of interest form and Declaration.

**Failure to comply** with the above requirements may result in the disqualification of the nomination. Nominees are urged to apply in accordance with a format as provided for in the Spatial Planning and Land Use Management Regulations: Land Use Management and General Matters, 2015.
