QUOTATIONS: REFURBISHMENT OF DZATA RUINS BUILDINGS

All interested service providers are hereby invited to submit written quotations and deliver them to the Municipality's tender box. Quotations are only needed for labour. Service Providers are requested not to include material in their quotations. Compulsory site inspection will be held on **Monday, 07 March 2011 at 10H00** and bidders are requested to meet **Mr Raleshuku** at the site (**Dzata Ruins**) **Dzanani Vhutuwangadzebu**

The scope of work is as follows:

- **Thatch roof at the gate must be properly arranged and 100mm thick concrete slab to pave road**
- **A purpose made thatch roof ridge for all building**
- **Treatment for insects on all existing thatch roofs and close all water dripping openings**
- **Remove damaged display cabinets parts and install new ones**
- **Cast 75mm high concrete apron 20MPA around the buildings**
- **Apply and compact 50mm gravel top soil on the demarcated area from the gate to the buildings**
- **The ablution block must be in working order**
- **All materials for thatch roof must be insecticide treated**
- **Areas must be measured by the contractors**

Requirements

- **CIDB Certificate one (1)GB**
- **Original valid Tax Clearance Certificate from SARS**
- **Copy of ID for owners/directors**
- **Copy of company registration certificate (CK)**

Quotations must be as follows:

1. be signed by an authorized person of the supplier
2. be on an original letter head of the company/enterprise
3. be valid for a period of sixty (60) days from the closing date
4. clearly indicate the price charged vat inclusive
5. be accompanied by an original valid SARS Tax Clearance Certificate.
6. be accompanied by fully completed MBD 6.1 obtainable from the municipality or can be downloaded from municipal website www.makhado.gov.za.
