- Steel palisade panel welded 25 x 25 x 1.8 x 3.0
- Post palisade 76 x 76 x 1.6 x 2.4m
- Paint all steel work by red oxide primer and then by G33 Windsor green
- All the holes must be 400 x 400 x 500 deep
- The concrete to be casted in each hole must be 15mpa in strength
