- 10x2.3m Standard Pre-cast poles
- 48 x 1.5m Standard Louvre pre-cast Panel
- Cement
- Provide and Install 6 x square concrete table and concrete benches on to 1.8m x 1.8m x 100mm x 50mm thin concrete floor slab finishes with steel trowel. (Table size: 1300mm x 700mm x 50mm thick, height 750mm and Bench Size : 1300mm x 450mm x50mm thick and Height 390mm Footing)
