- 6Kw crank start diesel or 5.8 Kw recoil start petrol engine
- Recirculating 2m Spraybar with 65 degree flat fan two ways shut off adjustable nozzles welded at 100mm centres, linked to central shut-off lever.
- Mild steel welded emulsion tank of 1000 litre with 150mm heating coil, temperature gauge, all control valves for refilling and calibrated dip stick and manhole.
- 700 000 / or one million BTU LP gas burner for clearing stoppage and 40kg bottle holding bracket
