1. THAT Council designate Mr M J Kanwendo to act in the capacity as Municipal Manager in terms of the provisions of section 54A (1) (b) of the Local Government Municipal Systems Act, No 32 of 2000 for a period of three (3) months with retrospective effect of 3 September 2017 for a further period not exceeding three (3 months) during which the appointment of a permanent municipal manager must be formally concluded. (DCS)

- 2. THAT Council apply for approval by the MEC for Local Government in terms of the provisions of Section 54 A (2A) (b) of the Local Government Municipal Systems Act, No 32 of 2000, that Director Community Services, Mr M J Kanwendo continue to act in the capacity as Municipal Manager for a further period of three (3) months commencing on 3 September 2017. (DCS)
- 3. THAT Mr M J Kanwendo, Director Community Services, be appointed as acting Municipal Manager for such period when the acting capacity will automatically come to an end when the Municipal Manager is appointed by Council and he assumes his responsibility as Accounting Officer. (DCS)
