# FINANCES: FINAL APPROVAL OF 2008/2009 ESTIMATES (6/1/1(08/09))

### **REMARK:**

- 1. Cllr A du Plooy proposed that the property rates for business category properties be determined at 0,0045c per rand and for residential category properties be determined at 0,003c per rand. The proposal was not seconded. The Executive Committee's recommendation was generally accepted as Council Resolution as recorded herein below.
- 2. Cllrs M A Helm of the ACDP and Cllr M K Maboho of the DA requested that the objection of their parties against this Council Resolution be recorded

- THAT the Capital and Operational Estimates for the 2008/2009 Financial Year as more fully recorded in Annexure A attached to the report in this regard be approved and that the Accounting Officer proceed with the implementation of the budget in 2008/9 financial year in terms of section 24 of the Local Government: Municipal Finance Management Act, 2003. (DF)
- 2. THAT it be noted that the estimated revenue to fund the 2008/9 budget will amount to R339 605 801 against a total estimated expenditure of R339 573 971, resulting in an expected surplus of R31 830, taking into account the depreciation of assets expenses, funded by reserves and accumulated surplus, and that total Capital Project expenditure is R59 632 100 funded by different sources as more fully recorded in Annexure C and Annexure D attached to the report in this regard, subject to amendment in terms of the purport and contents of paragraph 4 herein.

- THAT the proposal to acquire new vehicles to the estimated value of R4,1 million as more fully detailed in Annexure E attached to the report in this regard, which will be financed through a full Vehicle Management and Maintenance Scheme as provided for in the Operational Budget, be noted. (DF)
- 4. THAT Council approves the tariffs for municipal services as more fully set out in Annexure 1 attached to the report in this regard, and that it be promulgated accordingly for implementing on 1 July 2008, save the 2008/9 Property Rates tariff and the 2008/2012 Valuation Roll that will be implemented on 1 February 2009, with the following amendments:
  - 4.1 Item 3 Fees for accommodation at Tshikota must be based on a cost recovery principle.
  - 4.2 Item 4 Lease of Beer Garden R300,00
  - 4.3 Item 17 Lease of Halls and Tea Garden at Show Grounds R300,00
  - 4.4 Item 18 Lease of Show Hall and other Municipal Halls (1) R450,00
  - 4.5 Item 26 Property Rates By inserting the following category:
    "26.7 Property Rates on Agricultural Land and Rural Area Land 0,125c per Rand (0,00125 factor)" (DF)
