(COUNCIL LAND) PROPOSED PURCHASE, SUBDIVISION, REZONING OF LAND SITUATED BETWEEN HILLSIDE COMBINED SCHOOL AND ERVEN 1895-1897, DZANANI TOWNSHIP (7/3/2/1 & 7/4/1/4)

THAT the application of Messrs A. P. Nemutavhanani, T. D. Manena and A. E. Ramakoma to purchase, subdivide and rezone agricultural zoned land between the Hillside Combined School and erven 1895-1897, Dzanani Township, be approved in principle, subject to the following conditions and procedures:

- 1. The intention to perform a land sale transaction must be advertised in terms of the provisions of the Local Government Ordinance, 1939 (Ordinance 17 of 1939) in order to call for objections, if any
- 2. The property be developed within three (3) years from the date of signing the Deed of Sale, provided that Council may allow an extension of further Two (2) years
- 3. In the event that the developer failed to complete the development as required under paragraph 3 above, the property revert back to Council without compensation by the Municipality to the developer for any improvements on the property.
- 4. A professional land surveyor be appointed to subdivide the land into three equal portions and a Town Planner be appointed to rezone or amend the conditions of township establishment from Agricultural to Residential.
- 5. A market related valuation of the subdivided and rezoned portions be acquired which will serve as the purchase price.
- 6. Council's attorneys must register a separate Title Deed for the three subdivided portions zoned residential.
- 7. Council appoint at the cost of the applicants, a professional town-planner and the Land Surveyor referred to in paragraph 4 above.
- 8. It be a condition of the Deed of Sale to be concluded with the respective purchasers that the land is sold "voetstoots" and that the purchasers indemnify Council from any possible damages or losses that may be suffered because of this transaction.
- 9. The cost for the services of Professional Land Surveyor, Council's Attorneys and the Town Planner in this regard, will be borne by the applicants.

- 10. The applicants are allowed to make provision for municipal services at their cost in order to expedite the installation of services, subject to the terms and conditions prescribed by the Directorate of Technical Services.
- 11. No guarantees can be given on bulk services availability since municipality is not the bulk service provider of water, sewer and electricity municipal services to the site, including tarmac roads will be subject to the <u>services installation program</u> of the Department Technical Services / Department Development and Planning; Council will not be liable for any claims of damage or loss suffered as a result of delays or slow progress with commissioning of municipal services according to the program.
