ANSWER

The reply that covers question 1 to question 7 is, with all due respect to Cllr J Lukheli, that the Municipality can only safely state that there are five cases regarding this question which are proceeding at a Disciplinary Appeal Hearing in civil proceedings at the Makhado Magistrate and in the Regional Court of Limpopo under respective cases no. 591/2016, 592/2016, 593/2016, 594/2016 and LP/LTT/RC/84/16, as well as criminal case reported under case number 80/02/2015 at Makhado SAPS. In the light thereof the matter is sub-judice and as such the other parts of the questions cannot be answered at this stage.”
