## COUNCIL LAND: PROPOSED SALE OF LAND: CORNER OF RISSIK STREET AND THE N1 - NATIONAL ROAD (PORTION OF ERF 4296, LOUIS TRICHARDT TOWNSHIP) (7/3/2/3/34 & 15/3/9)

## RESOLVED A.19.26.02.14 -

- THAT the application of Mr J. Gilfillan acting on behalf of the company Nilo Touch (Pty) Ltd for proposed purchase of land situated at the corner of Rissik Street and N1-National Road (Portion of erf 4296, Louis Trichardt Township) be approved in principle subject to the following conditions: -
  - 1.1. The lessee be consulted concerning the outcome of the Council Resolution,
  - 1.2. The intention to sell land situated at the corner of Rissik Street and N1 National road be advertised in a local newspaper for comments and objections, if any,
  - 1.3. A market related valuation be performed by a registered professional valuer which will serve as the purchase price for the property,
  - 1.4. The developer submits a development proposal for consideration by the Executive Committee,
  - 1.5. The property be developed within three (3) years from the date of signing the Deed of Sale, provided that Council may allow an extension of a further two (2) years,
  - 1.6. In the event that the developer failed to complete the development as required under paragraph 4 above, the property shall revert back to Council without compensation by the municipality to the developer for any improvements on the property,
  - 1.7. The developer must submit a full and detailed application including the development proposal for consideration,

- 1.8. The application must amongst other include Traffic Impact Study indicating the area where access will be provided, Environmental Impact Assessment report, flood-line information together with flood-line certificate and proposed sketch diagram,
- 1.9. The standard conditions for the sale of Municipal land will further apply.
- 1.10. The purchaser will be responsible for the rezoning of the land and Council will be not be liable in the event that rezoning is opposed by any stake holder.
- 1.11. The applicant be informed in terms of the provisions of item 17(t) read with item 18(4) of the Makhado Local Municipality Immovable Land Disposal Policy that a request in the above regard cannot be processed unless first confirmed in writing that he/she will bear costs related to the advertisements and valuation.
- 1.12. The approval is further subject to the following conditions:
  - 1.12.1 <u>Electricity</u>: Erf 4296 has an existing electricity supply capacity of 100 kVA. Should this capacity be insufficient, any additional supply would be subject to-
  - (a) Overall availability of capacity in the Municipality's electricity supply scheme
  - (b) A fully motivated written application by the client which will be submitted to Senior Management for their consideration
  - (c) Only a maximum of 50kVA may in any way be considered according to present status of the electricity supply scheme

The client is further obliged to comply with the following conditions:

- (d) Application for additional electricity supply must be done by a professional electrical engineer, who must also do the design thereof and supervise all installation work
- (e) All installations must comply with the Electrical Installations Regulations promulgated under the Occupational Health and Safety Act, 1993
- (f) Only a registered 3 phase installation electrician may be permitted to install, test and certify the installation work, which must be submitted to Municipality
- (g) Actual costs plus an electrical engineering contribution proportional to the additional demand on the electricity supply scheme will be payable by the client upfront

1.12.2 <u>Water</u>: The Municipality is an operational agent of Vhembe District Municipality who is the WSA and therefore no comments can be given about water supply capacity.

1.12.3 <u>Sewer</u>: The Municipality is an operational agent of Vhembe District Municipality who is the WSA and therefore no comments can be given about sewer supply capacity.

1.12.4 Property Rates:Since Council is the landowner no property rates ispresently collected in respect of this land.(DDP)
