4. THAT it be noted that the Municipal Manager will sign the Employment Contract and Performance Agreement of the Director Development Planning on behalf of Makhado Municipality as dictated by legislation. (DCS)
5. THAT Council informs the MEC for COGHSTA of the appointment of Director Development Planning within 14 days of the Council Resolution. (DCS)
