7. QUESTIONS OF WHICH NOTICE HAD BEEN GIVEN

7.1 <u>QUESTION RECEIVED FROM CLLR T A MARAGA ON 22 MARCH 2018</u>

The question that was received was dealt with under the provisions of Rule 37 of the Council's Standing Rules of Order, 2016 published in Provincial Gazette No. 2736 dated 29 July 2016. The Speaker put item 7.1 and ruled that the Chairperson of the Executive Committee reply to the questions. The Chairperson of the Executive Committee proceeded accordingly and replied to the five questions, as recorded below:

"1. The Council Resolution (A.66.29.05.14) 1.1 states that, "As custodians of public funds, the Council has an obligation to see to it that cash resources are managed as effectively as possible. Council has a responsibility to invest public funds with great care and is liable to the community in that regard."

Question:

Are you convinced that you have fully satisfied the above resolution by investing the public funds with VBS?

If yes, substantiate your response and indicate its relevance in satisfying the "great care" of public funds, and **if no**, give an account of the challenges you had and how you have addressed them if you did.

Reply:

Yes we were satisfied with the decisions of investment at that particular point in time, as the main objective was to improve municipal revenue, by earning interest on surplus funds which has always assisted the municipality to fund internal operational costs.

The municipality had analysed reasonable interest returns of various financial institutions before investing and also considered the unqualified audit opinion of the VBS Bank at the point of investing.

2. The Council Resolution (A.66.29.05.14) 1.2 states that, "*The investment* policy should be aimed at gaining the highest possible return without undue risk during those periods when funds are not needed. To bring this about, it is essential to have an effective cash flow management program".

Question:

Based on 2 above, how do you justify your financial sense in investing funds at a low interest rate financial institution of 8.8% while we have to borrow at a much higher interest rate of 10.99%?

Reply:

The municipality has not borrowed funds from VBS.

The municipality invests in comparing interest rates received from different banks taking into consideration the Reserve Bank market related lending interest rates as well as the interest rate offered by the bank which was 8,8%. We are not aware of the 10.99% rate being referred to.

3. The Council Resolution (A.66.29.05.14) 1.3 states. "This policy has been compiled in accordance with the Local Government: Municipal Finance Management Act (MFMA), Act no 56 of 2003 and the Investment and PPP Regulations for the MFMA published in Government Gazette 27431 dated 1 April 2005."

Question:

May you please refer us to sections and sub-sections of the above quoted policy and Regulations that guided you in taking the resolution to invest public funds with an inferior financial institution such as the VBS.

Reply:

Investment was based on the Municipal Finance Management Act (MFMA).

The municipality used the investment policy as per Council resolution referred to (A.66.29.05.14) which is also aligned to the MFMA. The relevant section which guide processes of determining investment procedure is section 8 of this policy.

4. According to Council Resolution (A.66.29.05.14) of (29 May 2014) 7.1.1 "Money, especially large sums of money, must be invested with more than one institution in order to limit the risk exposure of the Municipality".

Question:

Which other institutions have the municipality invested the public funds in? Also substantiate the process you have undergone in identifying and ultimately arriving at the resolution to choose and invest with them.

If the VBS is the only one, fully justify the grounds that led to your decision to flouting the above resolution.

Reply:

Yes. VBS is one of the banks we invested in.

Other banks since 2014 are: FNB, ABSA, INVESTEC and NEDBANK. Investments are based on obtaining and comparing interest rate quotations received from different banks as per policy referred to above. The bank's performance was analysed based on the unqualified audit reports."

"NOTICE OF MOTION IN TERMS OF CLAUSE 28 OF THE STANDING RULES OF ORDER: DEMARCATION AND SERVICING OF 1000 SITES FOR TSHIKOTA TOWNSHIP RESIDENT

WHEREAS

- 1. The residents of Tshikota location demarcated and occupied municipal owned land.
- 2. The demarcation and occupation gave rise to legal tensions between the Municipality and Tshikota residents.
- *3.* This shows that there is serious need for residential land by Tshikota Location residents.
- 4. Preventing the residents of Tshikota Location from demarcating and occupying municipal land is not a solution.
- 5. The need for residential land is rising by day and agitating Tshikota Location residents to take extreme measures.

NOW THEREFORE THE EFF RECOMMEND THAT IN THE NEXT COUNCIL SITTING THE HOUSE DEBATE AND RESOLVES:

- 1. That Makhado Local Municipality demarcate and service 1,500 sites for Tshikota Location residents.
- 2. That the demarcation and servicing of sites be done as a matter of urgency.
- *3.* That the demarcation and servicing of sites be done in the 2018/2019 budget period.
- 4. That Makhado Local Municipality make land available for the demarcation and servicing of sites.

The Speaker enquired if any other proposals were at hand. Cllr D Ratshikuni on a point of order proposed that the motion could not be considered because Council has already approved its minutes of the 132nd meeting of 27 March where this matter was resolved.

Cllr G Tshibvumo proposed that the motion be discussed and that the Speaker must bring the matter to the vote by the show of hands.

The Speaker ruled that the motion had lapsed as existing Council Resolutions of 27 March 2018 already addressed the matter.

Cllr G Tshibvumo, A Matumba, A A Raphalalani, S S Tshifura, N A Mafhala, M G Phoshoko, M A Selapyana and M E Malima left the Chamber and did not return.

Motion No. 226 was not considered since it had the intention to amend Council Resolution A.29.27.03.18 and Council Resolution A.33.27.03.18 approved by Council on 27 March 2018, and therefore still within three months preceding the date of Council meeting on which said Motion was submitted.

11.2 MOTION NO. 227: RECEIVED ON 16 APRIL 2018

Motion no. 227 dated 13 April 2018 was submitted in terms of the provisions of clause 28 of the Council's Standing Rules of Order, 2016 published in Provincial Gazette No. 2736 dated 29 July 2016, proposed by Cllr T A Maraga and seconded by Cllr M C Nematandani.

The Speaker, Cllr L B Mogale called the proposer of the motion to read the motion.

The proposer, Cllr T A Maraga proceeded to read Motion No. 227 as follows:

"NOTICE OF MOTION IN TERMS OF CLAUSE 28 OF THE STANDING RULES OF ORDER: RDP HOUSES BUILT IN WARD 24 IN THE YEAR 2000

WHEREAS

- 1. The building of RDP houses in Muduluni, Madodonga and Madabani in the 2000 list was done; and
- 2. The following RDP houses amongst them are no longer in good conditions/dilapidated and they are not safe to people residing in them on their daily lives.
- 3. The house of Mr Matshavha S M, ID no 3405050549086 of stand no. 336
- 4. Mahangwahaya M J, ID no. 634060447083 of stand no. 188
- 5. Nkhumeleni M, ID no. 4011030420080 of stand no. 128
- 6. Ramanala T E, ID no. 4301190226082 of stand no. 158
- 7. Malefo M R, ID no. 6703040288089 of stand no. 369

ALL THE ABOVE RESIDENTS RESIDE AT MUDULUNI VILLAGE; AND ALSO THE FOLLOWING RDP HOUSES IN MADODONGA VILLAGE:

- 8. Mukwevho Raisivhe Marthar, ID no. 4304040852085 of stand no. 290
- 9. Mboweni Emily, ID no 6412121165089 of stand no. 1039
- 10. Maphutha Thomani, ID no. 6609115054084 of stand no. 1225
- 11. Tshikumbu Muthelo Philemon, ID no. 5707035655088 of stand no. 1030

12. All the above-mentioned RDP houses have terrible cracks, in rainy days, the walls become wet inside and also leaks water through the roofs. These conditions are extremely dangerous to the lives of all the occupants in these RDP houses.

NOW THEREFORE THE COUNCIL:

RESOLVES:

That the immediate attention to this matter is of utmost importance.
 That the available grant/funds must be used to this situations before we lose the life of people of our community on 2017/18 financial year.

The Speaker enquired if the seconder was present. The seconder, Cllr M C Nematandani confirmed her presence.

The Speaker pointed out that the Department of Co-operative Government, Human Settlement and Traditional Affairs is the authority who holds jurisdiction of the so called RDP houses referred to in Motion No. 227 and therefore ruled that the Motion would for this reason be disallowed.

Therefore Council did not consider Motion No. 227.
