# REPAIR OF SLIPPERY GRAVEL ROAD BETWEEN TSHIVHUYUNI TO MADUWA – WARD 5

WHEREAS MAKHADO LOCAL MUNICIPALITY is responsible for the maintenance of municipal roads and WHEREAS the gravel road between the Village Tshivhuyuni to the Village Maduwa located in Ward 5 is in an exceptional poor condition, and the road is used daily by the residents of the two said villages to travel from home to the place of

work, be it Elim or Makhado Town, and the road is also used extensively by emergency vehicles such as ambulances.

NOW THEREFOR the Council resolves that the maintenance and improvement of this gravel feeder road is a priority in the 2019/20 financial year maintenance program, and rules that the Director Technical Services arrange with immediate effect for the necessary maintenance works by amongst others—
