PROTECTION OF THE MUNICIPAL MANAGER AND THE MAYOR: THREAT TO LIFE INCIDENTS (8/1/2/1/1 & 7/2/5)

REMARK:

- 1. When this item was considered, the Chairperson of the Executive Committee, Cllr F D Mutavhatsindi and the Municipal Manager, Mr I P Mutshinyali recused themselves from the meeting.
- 2. Cllr R Ludere proposed, duly seconded by Cllr M R Selepe that the following statement "The threats seemed to have emanated from the suspension of the Manager Finance Expenditure who was suspended during December 2014. In the February 2015 Executive Committee meeting there was also a heated debate between Councilors on whether it was proper for the Municipal Manager to have approved the recommendations by investigators to suspend the Manager Finance Expenditure. The unknown armed people also indicated that they had been sent by a woman and amongst people who benefitted of money transferred, there is also a woman. It was during this period that the Mayor also was tipped of threats against his life and the threats were mainly targeting the Mayor when he is using the official mayoral car." be removed from the report. The proposal was accepted in general and recorded in Council's Resolution.
- 3. Cllr R S Baloyi recused himself from the meeting when the matter was considered and did not return again.
- 4. Cllr S Masuka proposed, duly seconded by Cllr T P Mamorobela that the following statement "With all due respect to Council in this circumstance the facts positively point that there is a causal nexus between the threat to the life of the Municipal Manager and his duty as an employee of the Makhado Local Municipality to approve recommendations to suspend or dismiss any employee for misconduct. The facts are corroborated by the fact that the Municipal Manager has under oath deposed an affidavit at SAPS Makhado in which he as accounting officer had to open criminal charges against the unknown perpetrators who are still at large. Under normal circumstances, those who are unsatisfied or believe otherwise, are at liberty to press charges of perjury against the Municipal Manager at the nearest SAPS Centre, which if the contents of the affidavit deposed by the Municipal Manager are found to be untrue, the Municipal Manager will be prosecuted and found guilty of perjury which will also constitute a serious misconduct that may result in his dismissal." be removed from the report. The proposal was accepted in general and recorded in Council's Resolution.

- 1. THAT note be taken of the report about emergency protection services that had to be arranged for Council's Municipal Manager and Mayor during March 2015 when his life was threatened due to a causal nexus with his duties as accounting officer. (DCOMS)
- 2. THAT the action of the Mayor to authorise that reputable VIP Protection Service Provider be sourced, **be ratified**, in view of the special circumstances of the case as recorded in the report with a total cost of R300 900-00. (CFO)
- 3. THAT it be noted that the procurement of protection services under section 36 of the Supply Chain Management Regulations was reported under separate cover along with other deviations for quarter 3 of 2015/2016. (CFO)
- 4. THAT a policy on protection and security of officials and councilors be compiled and submitted to Council. (DCOMS)
- 5. THAT the contents of the report be amended in that the wording read out by Cllr R Ludere be regarded as not part of the official Council records. (DCS)
- 6. THAT the contents of the report be amended in that the wording read out by Cllr S Masuka be regarded as not part of the official Council records. (DCS)
