- 6. THAT Makhado Municipality must pay funds to the Community Trust account to enable registration of land into the Council's name. (DDP)
- 7. THAT the Council with the responsibility of the Director Technical Services is responsible for the fencing of site which will belong to the Makhado Municipality. (DDP)
- 8. THAT Council agrees in principle that the land be purchased, but that the final purchase price for the land should be first submitted to Council for consideration. (DDP)
