The project commenced on the 20 July 2015.

- Build SCOA ledger Completed. 2121--- SCOA "items" built. These are combinations of selections made from point 1 above.
- 3. Aligned MC to SCOA ledger completed
- 4. Migrated balances from MC to SCOA completed.
- Reconciling balances as at 30 June 2014, 30 June 2015 as well the current trial balance (2015/2016). Identifying splits in PPE and system enhancements. Target date 6 November 2015 – Completed
