DRAFT TRANSPORT ALLOWANCES POLICY, 2018/2019

Car Allowance Policy Review

Presently the fixed transport allowance is based on fixed kilometer distances as follows:

Post level 1 incumbents - 1150 km per month

Post level 3 incumbents - 950 km per month

Post level 4 incumbents - 900 km per month

Post level 5 incumbents - 850 km per month

Post level 6 incumbents – 800 km per month

The recommendation therefore is a uniform fixed monthly transport allowance to incumbents who presently participate in the transport allowance scheme as follows which the increase will be based on the MFMA budget circular 85 guidance for 17/18 of 7.75%, but will reduce to actual SALGA increase on 1 July 2017 once promulgated:
