The general purport of the Council Resolution is an increase in all the relevant charges in order to cope with increase in the operational costs. The above tariffs have increased by 4.6%, with exception of electricity tariffs which have increased by 6,22% for the 2020/21 financial year with effect from 1 July 2020.

26. Assessment Rates

The general purport of the Council Resolution is a 4.6% increase of the existing rate in the rand for respective categories of properties based on the valuations recorded in the 2018-2023 Valuation Roll which will be collected on a monthly basis or annual basis as per the requirements per individual customer.

Any person wishing to object to Council's determinations may do so in writing to reach the Municipal Manager within twenty one (21) days calculated from 1 June 2020.
