TENDER NO. 05OF 2011(Re-advertised tender) PROPOSAL FOR THE PROVISION AND MAINTENANCE OF CCTV CAMERAS IN AND AROUND MUNICIPAL PREMISES FOR A PERIOD OF FIVE (5) YEARS

Suitable service providers are invited to submit proposals for the Provision and Maintenance of CCTV Cameras in and around Municipal premises for a period of five (5) years. Bid documents will be available on Tuesday, 22 March 2011 at Procurement Section, Office no. B043, upon payment of a non-refundable amount of R200, 00

NB. This is a re-advertised tender, service providers who have purchased the previous bid document (Tender No 69 of 2010) must bring proof of payment to Procurement Office and tender document will be issued to them at no extra cost. Bidders are kindly requested to attend **a compulsory** briefing session on **Friday, 25 March 2011 at 10:00** in the Executive Committee Chambers, First Floor, Civic Centre, No. 83 Krogh Street, Louis Trichardt. Qualified bidders would be invited to make presentation to the Bid Evaluation Committee on how best they would provide and install CCTV Cameras that will meet our expectation. In the documents which must form part of the presentation, bidders must also include contactable references where they have provided the same services as indicated above.

After briefing session service providers will be expected to submit proposals which include installation and maintenance CCTV Cameras to the Makhado Municipality, and price must be vat inclusive. Bidders must therefore submit a fully completed proposal document signed by a duly authorised person, sealed in an envelope and clearly marked on the outside: "*Tender No. 05 of 2011 for The Provision and Maintenance of CCTV Cameras - Makhado Municipality*", and must reach the undersigned by depositing it into the tender box at the foyer of the main entrance to the Civic Centre by no later than **12:00 on Tuesday, 12 April 2011**, where all tenders received will be opened in public in the Executive Committee Chamber, First Floor, Civic Centre, No. 83 Krogh Street, Louis Trichardt.

The Municipality is not bound to accept the lowest or any bid and reserves the right to accept any part of a bid. Bids must remain valid for a period of ninety (90) days after closing date of submission thereof. Bids will be assessed on 90/10 score points.

Bids which are late, incomplete, unsigned or submitted in pencil or by telegraph or facsimile or electronically by e-mail, or not having the following documents attached for evaluation or not complying with the briefing sessions, will not be evaluated and will be disqualified:

- Original valid Tax Clearance Certificate
- A certified copy of Company Registration Certificate
- Certified copy/copies of company owner's ID Book/s.
