The men's Zoom Vapor 9.5 Tour has a textile upper, flex grooves, a TPU footframe and a Dynamic Fit system designed for a lightweight-responsive feel on the court.

Upper: Textile material provides a lightweight, breathable fit.

Midsole: Phylon midsole for lightweight, yet firm cushioning and optimal responsiveness

Outsole: Rubber outsole with XDR compound on the heel and forefoot for multi-surface traction and durability.

Dynamic Fit system wraps the midfoot and arch for a glove-like fit.

Deep flex grooves for enhanced articulation and natural movement.

TPU foot frame wraps from the lateral midfoot to the heel for stability during quick turns.
