***The following inspections, safety tests and repair work on essential equipment are done to ensure safety of our personnel and to prevent injury to users of that equipment:***

- 1. Load test is done to all hoist equipment, chain blocks and lever hoists. “Driven Masjine Reg . 18: 5,6 and DMR 16:5,6 and 7” .**
