2	<b><u>CEILING</u></b> ✓ Remove and replace ceiling of 7.5x4.8m <sup>2</sup>
3	<b><u>WALL TILLING</u></b> ✓ Remove and retile 40x5.8x2.1m <sup>2</sup>
4	<b><u>FLOOR TILES</u></b> ✓ Tile 1.7x1.10m <sup>2</sup> x3(shower mosaic)
5	<b><u>PAINTING</u></b> ✓ Paint 7.5x4.8x800m <sup>2</sup> by G377 enamel
6	<b><u>DOORS</u></b> ✓ Replace three toilet doors and one outside and paint by aqua pool and replace one outside door and lock
7	<b><u>WINDOW</u></b> ✓ Remove and replace all broken window pains and paint
8	<b><u>OUTSIDE PAINTING</u></b> ✓ Prepare and finish with tapioca G377 and trim by G33 1.2m from the ground level.

6	<b><u>DOORS</u></b> ✓ Remove, replace and paint six toilet doors and door frames by G6-A1-4(Aqua pool) and replace one outside door frame together with door and lock
