## 1.0 INTRODUCTION

Makhado Local Municipality is hereby seeking for quotations from suitably qualified service providers to facilitate a strategic planning session for the municipality. The review focuses on Makhado Local Municipality's Integrated Development Plan (2022/23 – 2026/27), reviewing service delivery performance of the 2024/25 financial year and planning for the preceding years.

#### 2.0 SCOPE OF WORK

The scope of work is as follows;

- Review the current strategic plan of the municipality;
- Review progress made against the programmes and project as set out in the IDP;
- Conduct a three (3) day strategic planning review session with management of the municipality;
- Review performance and programme and consolidate into draft IDP review;

### CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids<sup>1</sup> invited.
- Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).<sup>2</sup> Collusive bidding is a *pe* se prohibition meaning that it cannot be justified under any grounds.
- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:
