All interested service providers are hereby invited to submit written quotations for the **hiring of bull dozer for leveling, compaction and covering disposed waste: vondeling Landfill Site**

The Specification is as follows:

- One **D5 bulldozer** (steel wheeled) for pushing and leveling waste to recommended thickness.
- Covering the leveled waste by soil.
- **Quoted prices should be per hour and only wet rate is required.**
- Bulldozer should come with the operator for a period of three (03) months

Requirements

- **Valid Original Tax Clearance Certificate**
- **Copy of company registration certificate**
- **Certified copy/copies of company owner(s) ID Books**
- **BBBEE Certificate**
- **Proof of Payment of Municipal Accounts or Bills**
- **The company must have a good reputation of landfill technical knowledge and experience.**
- **The company must have worked at the landfill site performing the levelling, compaction and covering of waste according to the requirements as outlined in the permit/licence, of which a proof (appointment letters for such activity and /or a letter from the landfill owner where similar work was performed) must be provided**

Quotations must be as follows:

1. be signed by an authorized person of the supplier
2. be on an original letter head of the company/enterprise
3. be valid for a period of sixty (60) days from the closing date
4. clearly indicate the price charged vat inclusive
5. Be accompanied by an original valid SARS Tax Clearance Certificate.
6. Be accompanied by fully completed MBD 6.1 and MBD 4 obtainable from the municipality or can be downloaded from municipal website www.makhado.gov.za.

Fully priced and signed quotations must be sealed in an envelope clearly marked quote number **“MAK26/2015-2016 description “HIRING OF BULL DOZER FOR LEVELING, COMPACTION AND COVERING DISPOSED WASTE: VONDELING LANDFILL SITE”** and be deposited in the tender box at the foyer of the Civic Centre at the physical address reflected below by no later than 12H00 **of 11 SEPTEMBER 2015**

Quotations received will be assessed in accordance with the Municipal Supply Chain Management Regulations, 2005 read with Council’s Supply Chain Management Policy and **80/20** points scoring will be used. Preference points will be allocated according to BBBEE rating.
