QUOTATION: SUPPLY AND DELIVERY OF WOOD CHIPPER MACHINE

All interested service providers are hereby invited to submit written quotations for the **Supply and Delivery of Wood Chipper Machine**

SPECIFICATION:

ONE (01) X WOOD CHIPPER MACHINE

The machine should have a horizontal slat style infeed conveyor 50cm X152cm wide driven by (1) 24 CID Hydraulic Motor and must also have two side infeed wings

- The machine should be \pm 88cm diameter capacities with the mill opening of 88cm X 152cm
- The feed wheel should be (1) 24 diameter X 5' wide floating feed wheel internally driven by a hydraulic motor/ Gearbox combination.
- The machine should have 42" diameter X 63' Cutter Mill consisting of 60 cutter bodies and teeth. The mill must cut material apart by rotating down toward the material
- The Cutter Head Shaft should have 15cm diameter spherical roller pillow block bearings.
- The patented cutter system must be able to cut, split and grind wood material
- The Big bite system must be able to slow the RPM of the head to improve the performance and quality of the end-product, while lowering operational cost.
- Both side of the machine must be branded with the municipal logo, Section
