All interested service providers are hereby invited to submit written quotations for the **Labour and Material for the Refurbishment of Caravan Park Building**

SCOPE OF WORK

Refurbishment of Caravan Park buildings

1. Roof

- Replace a 76 x 50 rotten timber (45m) on the overhang with the same size treated timber.
- All gutters to replaced (45m in length) except down pipes
- Paint 170 square metres IBR roof sheet by Windsor green G33 paint and all loose roof screws must replace, watertight roof membrane to be used on all replaced roof screw holes
- Remove the roof of the building facing southern direction (4.5 x 4) and reconstruct the roof using new treated timbers of the same sizes and ceiling. Internal wall must be painted by G377 paint. The ceiling must be painted by polvin white
- All cornice that are sticking to the wall must be replace by new cornice
- All exposed timbers that are new and exposed must be painted by Windsor green G33

2. Floor and wall

- Replace 150 x 150 white ceramic wall tiles (46)
- Use expansion joint on all cracks on floor and walls

3. Doors and windows

- All door and security locks must be replaced by heavy duty locks (commercial use)
- Window closing handle and adjustments must be installed

4. Plumbing

- ALL internal taps must be replaced by 15mm press and release taps
- Remove and replace four 150 Litres geysers
- Replace all mechanism in cistern
- Fix all leaks where necessary replace damaged pipes
- Shower head and taps must be replaced together with floor filtration drains
- All blocked gullies must be unblocked

Check the following before certifying your work as completed

- **ALL COMPLETED WORK AREA MUST BE CLEANED AND DUST FREE**
- **ALL RUBBLES MUST BE TRANSPORTED TO THE DUMPING SITE**
- **All appliances are tested and are in working condition**

Requirements

- **Valid Original Tax Clearance Certificate**
- **Copy of company registration certificate**
- **Certified copy/copies of company owner(s) ID Books**
- **BBBEE certificate**
- **CIDB GRADE 01GB**
- **CSD summary report**
- **Proof of payment of municipal bills, accounts and Service or statement/ Lease agreement / Letter from Traditional Authority**

Quotations must be as follows:

1. Be signed by an authorized person of the supplier
2. Be on an original letter head of the company/enterprise
3. Be valid for a period of sixty (60) days from the closing date
4. clearly indicate the price charged vat inclusive
5. Be accompanied by an original valid SARS Tax Clearance Certificate.
6. Be accompanied by fully completed MBD 6.1 and MBD 4 obtainable from the municipality or can be downloaded from municipal website www.makhado.gov.za.

Fully priced and signed quotations must be sealed in an envelope clearly marked quote number **“MAK50/2016/2017”** & description’ **LABOUR AND MATERIAL FOR THE REFURBISHMENT OF CARAVAN PARK BUILDING “** and be deposited in the tender box at the foyer of the Civic Centre at the physical address reflected below by no later than **12H00 of 30 SEPTEMBER 2016**

Quotations received will be assessed in accordance with the Municipal Supply Chain Management Regulations, 2005 read with Council’s Supply Chain Management Policy and 80/20 points scoring will be used. Preference points will be allocated according to BBBEE rating.
