TERMS OF REFERENCE/ SPECIFICATION

APPOINTMENT OF A CONSULTANT TO RENDER ENVIROMENTAL SERVICES AT MAKHADO LOCAL MUNICIPALITY LANDFILL SITES

1. PURPOSE

The purpose of the contract is to acquire the professional services of an Environmental Consultant, with extensive experience and technical competency to conduct groundwater and surface water monitoring at Makhado landfill site, groundwater monitoring and soil quality monitoring at Vondeling landfill site. Monitoring will be conducted using a standard monitoring system to ensure efficiency and consistency, also ensuring compliance to the waste management licenses (WML) for the landfill sites and investigating any environmental impact for the landfill sites.

The required services are guided by the mandatory requirement to ensure that Makhado waste management facilities comply with requirements contained in “The Minimum Requirements for Disposal of Waste by Landfill, The Minimum Requirements for Water Monitoring at Waste Management Facilities (DWAF, 1998), as well as other relevant regulatory framework.

2. BACKGROUND

The municipality has a total of two (2) landfill sites, with one landfill site being operational and the remaining one closed. The below table provide details of the waste management facilities:

3. SCOPE OF WORK

The consultant will be required to perform, amongst others, the following duties:

3.1 Water Quality Monitoring

The consultant is required to carry out analysis of ground and surface water on each site as prescribed by the Minimum Requirements issued by Department of Environment and Water Affairs (DWA), 1998. The ultimate goal for monitoring is to establish the trends in water quality and determine possible pollution which may be as a result of day-to-day operations of the landfill site and post closure.

Section 7 of the Minimum Requirements for Water Monitoring at Waste Management Facilities (Second Edition 2008) describes the Analytical Variables which are suggested in a comprehensive analysis and an indicator analysis. Ground and surface water samples should be submitted to an SANAS accredited laboratory. Provide ground and surface water sampling results. A detailed water quality report with the interpretation of the results must be submitted to the municipality. The samples will be collected from the following sites:

- Makhado landfill site- two (2) boreholes and leachate dam.
- Vondeling landfill site- two (2) boreholes.

3.2 Soil Quality Monitoring

The service provider is expected to compile a desktop study report detailing all available information. To carry out a site visit and walkover to assess the site in terms of topography, land cover, drainage and the overall physical appearance and current status of the site. Collect soil samples from within the landfill site for soil contamination analysis. Samples should be submitted to SANAS accredited Lab for analysis. Soil quality must be performed in and around the site and the monitoring results must be compared to the quality of soil collected 100 to 200 metres away from the closed site. six (6) samples should be collected. A detailed soil quality assessment report with the interpretation of the results must be submitted to the municipality.

- b) A laboratory analyst who will be appointed to analyse samples submitted at the laboratory for analysis.

7. EXPERIENCE/ REFERENCES

Bidders need to have successfully executed a minimum of two (2) projects in rendering of similar projects. Potential bidders are required to submit minimum of 2 contactable reference letters or appointment letters in rendering similar work.

For the reference letter to be deemed valid it must satisfy all the following:

- a) In the letter head of the institution offering the reference.
- b) Clear description of the services that were rendered and the start and end date of the project.
- c) Contact details.
- d) Dated.
- e) Signed/ stamped to indicate validity.

It is the onus of bidders to make sure that they provide contactable reference letters or appointment letters with corresponding completion. The municipality may verify the veracity of the provided submissions at any given time. Should the content of the information not be verifiable, the submissions will be disregarded, and the bidder will not be evaluated further.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
