SCOPE OF WORK

QUANTITY	DESCRIPTION
2	<ul style="list-style-type: none">• Surveying , sitting and drilling of +/- 50m deep (by qualified and competent service provider) of 1 x new ground borehole and equip it with 4mm steel casing and 1.5kw submersible pump with discharge pipe to the water tank (depth of borehole should be +/-m depending on the availability of water)
	<ul style="list-style-type: none">• Supply and installation of 1x 5000L water tank with 3m high steel stands (four feet casted onto 600mm x 600mm x 600mm concrete footing) and must be painted blue.)
	<ul style="list-style-type: none">• The price for total depth of the boreholes and casing should be based on the price of the rod and casing per metre and such prices should be indicated.
	<ul style="list-style-type: none">• Supply and connect 800w pressure pump connected to water tank and irrigation system (this pump must be protected from vandalism)
	<ul style="list-style-type: none">• Supply and installation of hose pipes, submersible water pump, power generator and wiring.
	<ul style="list-style-type: none">• Provide all electrical connection to the borehole pump system from the nearest electrical supply point.
	<ul style="list-style-type: none">• NB: The price should calculated based on the charge per metre ; therefore the price per meter should be included
	<ul style="list-style-type: none">• The drilled boreholes should be equipped with casings to the depth of each hole ; hence the price of each casing should be included
	<ul style="list-style-type: none">• The boreholes should be equipped with lockable device to prevent foreign objects to fall into.

REQUIREMENTS

- Valid Tax Clearance Certificate with Tax compliance status pin issued
- A copy of Company Registration Certificate/ CK.
- Certified copy/copies of company owner(s) ID Book(s). Not later than three (03) months.
- Certified copy of BBBEE Certificate or Affidavit (For Preferential Points). Not later than three (03) months.
- Attach Proof of payment of Municipal Bill/ Rates accounts/ Formal Lease Agreement, Letter from the Traditional Authority for both entity and directors of the company.
- A copy CSD Summary Report

Quotations must be as follows:

1. Be signed by an authorized person of the supplier
2. Be on an original letter head of the company/enterprise
3. Be valid for a period of sixty (60) days from the closing date
4. clearly indicate the price charged vat inclusive
5. Be accompanied by a valid SARS Tax Clearance Certificate.
6. Be accompanied by fully completed MBD 6.1 and MBD 4 obtainable from the municipality or can be downloaded from municipal website www.makhado.gov.za.
