APPOINTMENT OF A QUALIFIED SERVICE PROVIDER TO CONDUCT AIR QUALITY MONITORING (LANDFILL GAS MONITORING), DETERMINATION OF AVAILABLE AIRSPACE AND THE DETERMINATION OF THE HEIGHT OF THE OPERATIONAL CELLS OF THE LANDFILL SITE

Suitable and qualified service providers are invited to quote for Appointment of a qualified Service Provider to conduct air quality monitoring (Landfill Gas Monitoring), determination of available airspace and the determination of the height of the Operational Cells of the Landfill Site

TERMS OF REFERENCE

1. PURPOSE

The purpose of the contract is to acquire a qualified Air Quality Monitoring and Modelling experts, to conduct landfill ambient and sub-surface air quality monitoring of all related infrastructure associated with this monitoring i.e. sub-surface landfill gas (LFG) monitoring points, at operational and closed landfill sites, determination of available/ remaining airspace and the determination of the height of the operational cells at operational landfill site. There is no monitoring points presently installed at the landfills.

2. BACKGROUND

Makhado Local Municipality("herein The Municipality") is responsible for the management of solid waste in accordance with the National Environmental Management: Waste Act, 2008 (Act No. 59 of 2008). As part of compliance with environmental and operational requirements, the municipality seeks to appoint a qualified and experienced service provider to conduct:

- Air Quality Monitoring (Landfill Gas Monitoring);
- Determination of available landfill airspace; and
- Determination of the height of operational cells at Makhado Landfill.

The municipality has a total of two (2) landfill sites, with one being operational and the remaining one closed. The below table provide details of the waste management facilities:

3. OBJECTIVE

To ensure compliance with environmental legislation and improve landfill site management through professional monitoring and analysis of:

- Air quality and landfill gas emissions;
- Remaining airspace available for waste disposal; and
- Current cell heights to guide future cell development.

4. SCOPE OF WORK

The appointed service provider will be expected to deliver the following services:

4.1 Air Quality Monitoring (Landfill Gas Monitoring)

- Conduct field sampling of landfill gas emissions (e.g., methane, carbon dioxide, hydrogen sulphide), landfill odours, dust and other applicable air quality variables.
- Monitor ambient air quality for specific pollutants (e.g., PM10, VOCs, NOx, SO₂) to ascertain compliance to acceptable health standards.
- Hazardous air pollutants emanating from landfill operation may be dispersed as gaseous substances and this has to be monitored.
- Subsurface Landfill Gas Monitoring (LFG) concentrations should be monitored to assess the migration of LFG away from landfill boundaries and their release into the surrounding

environment which could lead to various hazards such as fire and explosion, health risks and can even cause damage to the environment.

- Use calibrated and approved equipment in accordance with South African National Standards (SANS) and Department of Forestry, Fisheries and the Environment (DFFE) guidelines.
- Compare monitoring results against acceptable limits as per NEM:AQA and SAQA guidelines.
- Monitoring for releases of volatile organic and/or inorganic substances should be conducted. These substances may be released as constituents in the landfill gas or through mass transfer from the liquid or solid phases of the waste to the gas phase.
- Provide a detailed monitoring report including analysis and recommendations.
- The gas monitoring reports must be landfill specific, and each individual site should be reported separately.

4.2 Determination of Available Airspace

- Conduct a topographical and volumetric survey of the entire landfill site using aerial drones, GPS/GNSS or other approved survey technology.
- Generate digital terrain models (DTM) and calculate:
 - Total used airspace;
 - Remaining airspace (in m³); and
 - Estimated landfill lifespan at current disposal rates.
- Submit results in GIS-compatible format and provide a comprehensive report.

4.3 Determination of Height of Operational Cells

- Conduct height verification of all active and completed landfill cells.
- Identify non-compliance or overfilling based on landfill design parameters.
- Present results through cross-sectional profiles, height maps, and photographs.
- The assessment must also include measurements of the height at which the active waste beam is being operated to establish if the height complies with the maximum permitted height restriction for the landfill site under survey.

5. DELIVERABLES

- Inception report detailing methodology and timelines.
- Full air quality monitoring report with results and recommendations for the two (2) landfill sites.
- Digital Terrain Models (DTM) and airspace volume report.

- Height assessment report of operational cells.
- GIS-compatible data and high-resolution maps.
- Close-out presentation to municipal officials.
- Copies of the reports must be provided as follows: two (2) hard copies for each site. Electronic version of report required. The reports shall be high quality colour.

6. EXPERTISE REQUIRED

- Professional Environmental Scientist/Engineer with landfill experience.
- Registered Land Surveyor or equivalent for airspace determination.
- Proven track record in air quality or landfill gas monitoring.
- Knowledge of South African environmental legislation and landfill regulations.
- Registered with the relevant Professional Body e.g. EAPASA, SACNASP, South African Geomatics Council (SAGC) etc.

7. DURATION OF THE PROJECT

The duration of the project is estimated at Six (6) weeks from the date of appointment. A project schedule and milestone delivery timeline must be included in the bid proposal.

8. REPORTING AND MONITORING

The appointed service provider will report to the Manager: Waste Management or designated municipal official. Progress meetings will be held as and when required until the project is completed.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.

- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
