Bids which are late, incomplete, unsigned or submitted in pencil or by telegraph or facsimile or electronically by e-mail, or not having the following documents attached for evaluation or not complying with the tender specifications, will not be evaluated and will be disqualified:

1. Tax Clearance Certificate status issued with a pin
2. A copy of company registration certificate.
3. Certified copy/copies of company owner(s) ID book(s).
4. Certified copy of BBBEE certificate (For preferential points)
5. Copy of registration with the Engineering Council of South Africa (ECSA).
6. Copy of membership certification with the South African Institute of Electrical Engineers (SAIEE)
7. Proof of payment of Municipal Accounts/Bills/Lease Agreement for rental/letter from Traditional Authority.
8. Copy of central supplier database summary report.
