Completed bid documents signed by a duly authorized person, sealed in an envelope clearly marked "**Tender No. 54 of 2017: "Appointment of Electrical Contractors for Electrification Construction: 2017/2018 to 2019/2020"**" must reach the undersigned by depositing it into the bid box at the foyer of the main entrance to the Civic Centre by not later than **12:00 on Friday, 18 August 2017** when all tenders received will be opened in public in the Executive Committee Chamber, First Floor, Civic Centre, No. 83 Krogh Street, Makhado.

The Municipality is not bound to accept the lowest or any bid and reserves the right to accept any part of a bid. Bids must remain valid for a period of ninety (90) days after closing date of submission thereof. Submitted tenders will be evaluated on 80/20 score points.

Bids which are late, incomplete, unsigned or submitted in pencil or by telegraph or facsimile or electronically by e-mail, or not having the following documents attached for evaluation or not complying with the tender specifications, will not be evaluated and will be disqualified:

1. Tax Clearance Certificate status issued with pin.
2. Copy of Central Supplier Database summary report.
3. A copy of Company registration Certificate.
4. Certified copy/copies of company owner(s) ID book(s). (Not later than three months)
5. Certified copy of BBBEE certificate (For preferential points)
6. Be in possession of a valid ORHVS certificate, with modules 1 to 10 or HVO-Level 04.
7. A copy of CIDB Grading of at least 3EPPE/4EP.
8. A copy of a Wiremen's License
9. A letter/certificate as proof of being registered with the Department of Labour as an Electrical Contractor with IE or ME (Installation or Master Electrician) number.
