Interested Service Providers are requested to bid for Supply and Delivery of Traffic Uniforms for Makhado Local Municipality for the period of 24 Months. Bidders are requested to bid as per specification attached to the bid documents that will be obtainable on **12 December 2017** at the Procurement Office No. B043 upon payment of a non-refundable amount of R 300, 00.

A compulsory **briefing session** will be held on **15 December 2017** at **10:00** at the Council Chamber, Ground Floor, Civic Centre, No. 83 Krogh Street, Makhado.

Completed bid documents fully priced and officially signed by an authorized person, sealed in an envelope clearly marked '*Tender no.99 of 2017: Supply and Delivery of Traffic Uniform for Makhado Local Municipality for the period of 24 months*' must be deposited in the tender box at the main entrance of the Civic Centre, No 83 Krogh Street, Makhado **not later than 12H00 Friday, 12 January 2018**

The Municipality is not bound to accept the lowest or any bid and reserves the right to accept any part of a bid. Bids must remain valid for a period of ninety (90) days after closing date of submission thereof. Submitted tenders will be evaluated on **80/20** score points.

NB: Only locally produced goods, services or works or locally manufactured goods with as stipulated minimum threshold for local production and content will be considered.

If the raw material or input to be used for a specific item is not available locally, bidders should obtain written authorization from the DTI should there be a need to import such raw material or input and a copy of the authorization letter must be submitted together with bid documents at the closing date and time of the bid. The exchange to be used for the calculation of local production and content must be the exchange rate published by SA Reserve Bank at 12:00 on the date of advertising this tender.

Only SABS approved technical specification number SATS 1286:2011 must be used to calculate local content.

Bids which are late, incomplete, unsigned or submitted in pencil or by telegraph or facsimile or electronically by e-mail, or not having the following documents attached for evaluation or not complying with the tender specifications, will not be evaluated and will be disqualified:

- Valid Tax Clearance Certificate with Tax Compliance Status Pin Issued
- A copy of Company Registration Certificate
- Certified copy/copies of company owner(s) ID Book(s). Not older than three months.
- Certified copy of BBBEE Certificate or Affidavit (For Preferential Points). Not older than three months
- Fully completed MBD6.2 declaration certificate and local content annexures
- Proof of payment of municipal accounts, statement/Formal Lease Agreement for Rental or Letter from the Traditional Authority. Not older than three months
- Copy of Central Supplier Database Summary Report.
