Bidders are requested to bid as per specification attached to the bid documents that will be obtainable on **20 October 2015** at the Procurement Office No. B043 upon payment of a non-refundable amount of **R300,00**.

Compulsory briefing session will be held on **23 October 2015** at **10:00** at Council Chamber, 83 Krogh Street, Makhado and proceed to Levubu Beaufort for site meeting.

Completed bid documents signed by a duly authorised person, sealed in an envelope clearly marked "**Tender No.60: Appointment of contractor to upgrade Beaufort west line 22kV overhead Line: 2015/2016.**" must reach the undersigned by depositing it into the tender box at the foyer of the main entrance to the Civic Centre by not later than **12:00 on Friday, 30 October 2015** when all tenders received will be opened in public in the Executive Committee Chamber, First Floor, Civic Centre, No. 83 Krogh Street, Makhado.

The Municipality is not bound to accept the lowest or any bid and reserves the right to accept any part of a bid. Bids must remain valid for a period of ninety (90) days after closing date of submission thereof. Submitted tenders will be evaluated on 90/10 score points.

Bids which are late, incomplete, unsigned or submitted in pencil or by telegraph or facsimile or electronically by e-mail, or not having the following documents attached for evaluation or not complying with the tender specifications, will not be evaluated and will be disqualified:

- Original and valid Tax Clearance Certificate
- Copy of Company Registration Certificate.
- Certified copy/copies of Company Owner(s) ID book(s).
- BBBEE certificate (for Preferential points)
- CIDB Grade 3EP
- Proof of payment of municipal Accounts/Statement.
- Be a qualified three phase LV electrician
- Be in possession of a Wireman's license
- Be registered with the DOL as an electrical contractor.
- Be in possession of valid ORHVS 1-10 certificate
- Be in possession of valid MV/HT operating certificate
