**PROVISION OF HEALTH CARE RISK WASTE COLLECTION AND TREATMENT SERVICES FOR THE PERIOD OF TWO YEARS**

Suitable service providers are invited to tender for the Provision of Health Care Risk Waste Collection and Treatment Services. Bidders are requested to bid as per specification attached to the bid documents that will be obtainable on **16 MAY 2017** at the Procurement Office No. B043 upon payment of a non-refundable amount of **R200,00**.

A compulsory **briefing session** will be held on **19 MAY 2017** at **10:30** at Council Chamber, Ground Floor, Makhado.

Completed bid documents signed by a duly authorised person, sealed in an envelope clearly marked "*Tender No. 23 of 2017: Provision of Health Care Risk Waste Collection and Treatment Services*" must reach the undersigned by depositing it into the tender box at the foyer of the main entrance to the Civic Centre by not later than **12:00 on Friday, 2 JUNE 2017** when all tenders received will be opened in public in the Executive Committee Chamber, First Floor, Civic Centre, No. 83 Krogh Street, Makhado.

The Municipality is not bound to accept the lowest or any bid and reserves the right to accept any part of a bid. Bids must remain valid for a period of ninety (90) days after closing date of submission thereof. Submitted tenders will be evaluated on **80/20** score points.

Bids which are late, incomplete, unsigned or submitted in pencil or by telegraph or facsimile or electronically by e-mail, or not having the following documents attached for evaluation or not complying with the tender specifications, will not be evaluated and will be disqualified:

- Valid Tax Clearance Certificate issued by SARS with pin
- A copy of Company Registration Certificate
- Certified copy/copies of company owner(s) ID Book(s), not more than 3 months
- Certified copy of BBBEE Certificate (For Preferential Points)
- All authorization documents for the Service Provider to handle/or transport HCRW
- Attach confirmation from the HCRW treatment(Incinerator) facility that the appointed Service Provider will bring HCRW
- Attach proof of appointment letter of similar previous successfully executing service **contract** value & client contacts.
- Proof of payment of Municipal accounts/ Lease agreement or letter from Tribal authority(not more than 3 months)
- Attach CSD report
