- A copy of company registration certificate/CK.
- Certified copy/copies of company owner(s) ID book(s), not older than three (03) months.
- Proof of payment of Municipal Accounts/Bills/Formal Lease Agreement for rental/letter from Traditional Authority not older than three (03) months for both entity and directors of the company.
- Copy of central supplier database summary report.

- **Service provider must submit their certified BBBEE verification certificate from verification agency accredited by South African National Accreditation system (SANAS) or sworn affidavit.**
