Requirements:* Bcom Accounting / Internal Audit, Bsc Computer Engineering/ Computer Networks/Software Engineering, B Degree in LLB/ Law equivalent qualification preferably with articles and / Practicing Attorneys with a Company or Commercial Law, CIA, CA, CICA, CIMA, CFE, PHD with experience in local government / public sector will be highly preferred. Candidates must have at least 10 years working experience. Expertise in areas of both Financial Management, Law, and Municipal Finance Management Act, Municipal Systems Act, Treasury Regulations and legislations regulating information communication and technology.
