Interested professional electrical engineers registered with the Engineering Council of South Africa (ECSA), and who are also affiliated to the South African Institute of Electrical Engineers (SAIEE), with extensive knowledge and experience of electricity revenue enhancement which includes energy losses control and the development of a new electricity tariff structure, are invited to bid for the tender to provide this service for two consecutive municipal financial year 2017/2018.

A compulsory briefing meeting will be held on **17 March 2017** at **11:00** in the Council Chamber, Ground Floor Civic Centre, 83 Krogh Street Louis Trichardt.

The Municipality is not bound to accept the lowest or any bid and reserves the right to accept any part of a bid. Bids must remain valid for a period of ninety (90) days after closing date of submission thereof. Submitted tenders will be evaluated on **90/10** score points and functionality.

NB: Minimum qualifying marks to qualify further evaluation is **75 points**.

Bid documents received on time will be opened in public in the Council Chambers just after the stipulated closing time of the tender on **31 March 2017** at **12:00**.

Bids that will be submitted after the stipulated time and date, or incomplete, unsigned, written in pencil, submitted in telegraph or facsimile or any electronic form, or not having the following attachment documents, will be disqualified at the evaluation stage:
