#### **REMARK:**

The Municipal Electoral Officer (MEO), Mr M Mapholi presided over the proceedings pertaining to the elections of local representatives to the District Council. The local IEC Officer, Mr K Mulovhedzi made a presentation regarding the elections in this regard.

Mr Mulovhedzi further advised that if all Council members are present at the meeting, it therefore means that Makhado Municipality would be represented by fourteen (14) members in District Council. Council was further advised by the IEC that the quota for each would therefore be 11 for ANC, 1 for DA, 1 for ACDP and 1 for the three remaining parties, i.e. XP, PAC and UDM.

The MEO ruled that the meeting be adjourned for an hour so that parties must complete their respective nomination list and that each nominated councillor must accept the nomination in person and in writing.

When the meeting reconvened the Chief Whip, Cllr R Selepe proposed that the parties in Council have unanimously agreed to submit one list of nominations and the proposal was seconded by Cllr J F Smalle.

The MEO then ruled that in that event there would be no need for an election by secret ballot and pronounced the names of the fourteen (14) councillors to represent Makhado Municipality at the District Council as duly recorded in the Council Resolution below.
