COUNCIL LAND: PROPOSAL TO LEASE THE CLOUD END HOTEL ON A LONG-TERM PERIOD OF 70 YEARS (8/3/2/18/30)

REMARK:

When this matter was considered Cllr N F Chililo proposed, duly seconded by Cllr M Mukosi that the term of Memorandum of Understanding be reduced from seventy (70) to fifty (50) years. The proposal was accepted and is recorded as Council's Resolution herein below.

THAT the proposed option 1 - long term Memorandum of Understanding to occupy the old Cloud End Hotel that was received from Mr Nesengani Makhado on behalf of Mutodo Properties (Pty) Ltd as recommended by administration be approved, subject to the following conditions:

- In terms of the provisions of section 79(18) of the Local Government Ordinance, 1939 (Ordinance
 17 of 1939) as amended the intention to lease the old Cloud End Hotel to the Mutodo Properties
 (Pty) Ltd on a long-term period of fifty (50) years be advertised in the local newspapers for
 comments and objections should there be any.
- 2. Option one as per applicant's proposal be approved for a period of fifty (50) years. The size of the allocated land be 35 hectares instead of the proposed 626,2076 hectares.
- 3. An amount of R45 200.00 will be a rental amount due and payable on the last day of each and every month.
- 4. Rental be escalated by 10% per annum at the beginning of each financial year until the end of the fifty (50) years of Memorandum of Understanding.
- 5. The fixed term of Memorandum of Understanding will be valid for a period of fifty (50) years.
- 6. Any omitted standard conditions for the lease of Municipal land will further apply.
- 7. The Memorandum of Understanding is subject to a review process for purposes of monitoring performance by both parties.
- 8. The Developer must start with the development within a period of two (2) years.
- 9. A standard Memorandum of Understanding be made by the Legal Office and entered into by and between Makhado Local Municipality and Mr Nesengani Makhado on behalf of the Mutodo Properties (Pty) Ltd.
