1. When this matter was considered Cllr N F Chililo proposed, duly seconded by Cllr M R Mokgodi that the actual increase in Determination of Upper Limits of Salaries, Allowances and Benefits of Different Members of Municipal Council be paid on 25 June 2022 as Council is directing the Mayor to get concurrence on such date.
2. That the administration be directed to check the affordability of the Municipality with the view of providing all part-time councillors with printers as purported in Item 14(e) of the Gazette.

THAT the provisions of Government Notice (Department Co-operative Governance and Traditional Affairs) No 46470, Determination of Upper Limits of Salaries, Allowances and Benefits of Different Members of Municipal Councils, in Government Gazette No 46470 dated 2 June 2022 be implemented by Council, as more fully recorded in Annexure B attached to the report in this regard: Provided implementation of the said upper limits of salaries, allowances and benefits of different members of municipal councils are subject to concurrence by the MEC for Coghsta, Limpopo. 2. THAT note be taken of the contents of SALGA Circular No. 16 of 2022 dated 7 June 2022 attached as Annexure A to the report in this regard. (CFO)
3. THAT it be noted that the annual total remuneration of upper limits for cellphone allowance for Councillors provided for in items 5 and 8 of Government Gazette No 46470 dated 2 June 2022 respectively, be paid and not exceed R3 400.00 per month inclusive of mobile data, in accordance with the applicable Municipal Council Policy. 4. THAT it be noted that the effective date of the Determination of Upper Limits of Salaries, Allowances and Benefits of Different Members of Municipal Council is from 1 July 2021 to 30 June 2022. (CFO)
5. THAT that the actual increase in Determination of Upper Limits of Salaries, Allowances and Benefits of Different Members of Municipal Council be paid on 25 June 2022 as Council is directing the Mayor to get concurrence on such date. (CFO/DCS)

6. THAT the administration be directed to check the affordability of the Municipality with the view of providing all part-time councillors with printers as purported in Item 14(e) of the Gazette.
