FINANCES: REPORT ON SPECIAL ADJUSTMENT BUDGET (2024/2025 FINANCIAL YEAR) (6/1/1(2024/25)

Report of the Chief Financial Officer

Summary

Makhado local Municipality received additional allocation for Municipal infrastructure grant (MIG) and integrated National electrification programme (INEP). The additional allocation is in terms of Government Gazette No.52381 issued on the 25^{th of} March 2025. The approved additional amounts are R 20 million and R 9 .089 million respectively for 2024 /2025 financial year.

Purpose

To seek approval from the Council to increase the approved adjustment budget for 2024/2025 financial year with an amount of R 20 million and R 9 .089 million on its capital budgets through special adjustment.

Legislative Background

Local government: Municipal Finance Management Act: Municipal Budget and Reporting regulations section 23 (3)

(1) If a national or provincial adjustment allocates or transfer additional revenues to the municipality, the mayor of the municipality must, at the next available council meeting, but within 60 days of the approval of the relevant national or provincial adjustments budget, table an adjustment budget referred to in section 28 (2) b of the act in the municipal council to appropriate these additional revenues.

Content

In compliance to the above section, management had revised the initial budget to accommodate the additional allocations of MIG and INEP of R 20 million and R 9 089 million received from National treasury DORA.

- Inclusion of the above-mentioned grants will increase our government grant allocation by R 20.089 million and capital expenditure will increase by the same amount.
- This grant will fund expenditure for capital for the following approved projects.

This additional allocation should be spent within 2024/2025 financial year 30 June 2025.
