ELECTRICITY TARIFFS AND CHARGES IN TERMS OF ELECTRICITY BY-LAWS

Notice is hereby given that Local Authority Notice no. 59 which was promulgated in Limpopo Provincial Gazette Extraordinary No. 2366 on 30 May 2014 is herewith amended in respect of only those items and to the extent of such items, reflected herein below (the rest of Notice No. 59 remains valid). These amendments are as a result of the approval by the National Energy Regulator of South Africa.

"3.2 Consumption of Electricity
